- 239 Application Zoning Law changes

__ Kevin Turley – Mayor

- Mayor Turley, Trustee Andrew Hartnett and Trustee Steve Messenger attended a meeting with Nate Wells and Carl Harding from HMI. There was discussion of assistance with paying Main Street in the future. Trustee Steve Messenger called to get quotes, requested that HMI fix the catch basins (which they agreed to) and will let Rebecca know if they plan to move forward this year or next spring. He is also meeting with the railroad to see where the right-a-ways are so they can do bump-outs where the trucks pull out and that its done in a legal manner.
- Regarding their water readings, it was discussed that it should be the Village Water Systems Operator that reads the meters. It is the Village's duty to verify water usage and recovery. Another question that was asked was regarding the loss of power and if the meters stopped working. If they are digital, that's a problem because it won't show the water usage while the power is out.
