__ Gina LaMonte – Codes Updates

- Received a building permit request from a private contractor on behalf of HMI for the following. Attorney Kathryn
 Festine suggested that if the board is ok with them doing so, she suggests that Gina require everything needed,

 - o <u>Scope of work requested</u>: Removal of existing pedestrian bridge structure that crosses the Sauquoit Creek and replace with new pedestrian bridge in the same location. Rough sf of new structure is 650 sf, 203 sf of this is added sf to the original footprint of bridge. Repair existing foundation piers to be reused, excavate for new footings, foundation walls for additional sf of new pedestrian bridge on parking lot side. Minor electrical work to replace in kind for new pedestrian bridge.
- Zoning Amendment was provided to the Board adding 1 and 2 permitted uses in the districts
 - o A motion was made by Deputy Mayor Greg Glinton and seconded by Keith Brennan to introduce the local law. All in favor. None against.
 - o A motion was made by Trustee Steve Messenger to declare this an unlisted action for SEQR and the Village as lead agency. It was seconded by Deputy Mayor Greg Glinton. All in favor. None against.
 - A public hearing will be held on Thursday, August 14, 2025 at 6pm at the start of the regularly scheduled board meeting. A motion was made by Mayor Turley and seconded by Deputy Mayor Greg Glinton. All in favor. None against.
