 - o Todd Prichard (BDR Trucking) to do landscaping Amanda requested his insurance information so that he can begin work when the ground thaws.
 - o Needs board approval of park items (picnic tables / benches) and is asking if there is storage space if they are ordered now, as she would like to keep reimbursement fund requests done before May board was supplied copies of quotes. - Abandoned white Lexus car on Main Street
 - o The attorney informed Rebecca that it is the Village's responsibility to have that car removed. Fire Chief Joe Inglis suggested towing it down to the Highway Garage until spring. Andrea has the keys to the car but the tires are flat. Gina suggested a tow company tow it and then scrap it. Mayor Turley would like to discuss what our options are legally in removing the car.
- HMI Demo Permit for part of the building submitted to Codes at tonight's meeting for approval
 - O Approved and will be issued Gina had a meeting with HMI. They will be doing a large project where they will not be changing the footprint and will be removing a part of the building and then will be rebuilding it but taller so that they can bring in more work, rather than at another plant. It does not affect site plans, zoning or flood plain.
